

List Bill, Payroll Deduction and Employer-Paid Rules

Guidelines to Set Up a List Bill/Payroll Deduction

- We will accept a minimum of 1 application
- A completed *Employer Disclaimer and Verification of Premium Payments* and *List Bill Premium Report* form (G1030-Rev 7/06 version) is required.
- A complete *Authorization to Disclose Premium Information to Employer* form (G1031) is required.
- List Bills and/or Payroll Deduction will be permitted in the states where World Insurance Company is currently marketing and as shown in the table/chart shown below. (Please Note: Such permission is subject to change based on state and/or federal laws and regulations.)
- The policy/certificate can only be set up on List Bill at the time of application.
- Automatic Premium Payment (APP) or Direct Monthly Bill – No Employer Contribution Allowed.
- Only the specific application fees should be submitted with the application, G1031 and G1030-Rev.
